

WABC's Need to Know Week of January 20, 2020

In the Legislature:

The second week of the Legislature kicks off with a plethora of bills related to asset building and protection, particularly consumer protection. With the short session timeline, bills have only a few weeks to be taken up by the legislative committees. Please read below for more information.

SUPPORT Children's Educational Savings Accounts

This legislation to study creating a statewide children's educational savings account program is expected to be introduced this week in both the House and Senate. Stay tuned for more information.

SUPPORT Expanding Retirement Savings Options (HB 2516)

Rep. Duerr's legislation to increase retirement savings options for workers whose employers don't currently offer a plan – mostly small and medium size businesses – was re-introduced last week. This legislation is particularly impactful for women and people of color, who historically have the lowest level of retirement savings, both nationwide and in Washington.

Status: HB 2516 was referred to the House Consumer Protection & Business Committee but has not yet been scheduled for a hearing.

SUPPORT Funding the Working Families Tax Credit (HB 1527 / SB 5810)

Legislation to fund the Working Families Tax Credit has been re-introduced again this year, allowing low-and-moderate income families to receive a credit on their sales tax paid to state and local governments. Similar to the federal EITC (earned income tax credit), this is a much-needed source of funding would provide economic relief to thousands of working families struggling to make ends meet. This ability to fund this policy is likely to be contingent on the passage of a capital gains tax, which is considered by all to be a significant legislative undertaking. SUPPORT Regulating Debt Buyers (HB 2476)

HB 2476 adds much-needed provisions to the state's Collection Agency Act to regulate "debt buyers" (those who purchase third-party debt, as opposed to debt collectors), primarily to require debt buyers to show proof of the debt prior to collection or seeking a default judgement. These are critical protections for consumers as the industry of purchasing debt

Status: HB 2476 was heard in the House Civil Rights & Judiciary Committee on Friday (1/17) and is scheduled for executive session on Friday 1/24.

OPPOSE "Pay to Pay" Debt Collection (SB 6118)

SB 6118 would allow debt collectors to charge a fee for paying debt on a credit card. This simply hurts consumers who are trying to pay down debt by increasing their costs.

Status: SB 6118 will be heard in the Senate Financial Institutions, Economic Development & Trade Committee on Thursday, 1/23 at 8:30am.

SUPPORT Access to Higher Education Transcripts & Registration (HB 2513 / <u>SB</u> 6140)

These bills would prohibit the current practice by higher education institutions of withholding transcripts and / or restricting registration for students who have unpaid debt with the institution. This critical issue of fairness has been introduced at the request of Lieutenant Governor Habib.

Status: HB 2513 will be heard by the House College & Workforce Development Committee on Wednesday, 1/22 at 1:30pm.
